## 2023 ERISA Section 104(d) Disclosure

This is the ERISA Section 104(d) Disclosure for **CHICAGO AND MIDWEST REGIONAL PENSION FUND** ("PLAN"), EIN 31-6126267, Plan Number 001, for the period January 1, 2023 to December 31, 2023. The annual report has been filed with the Department of Labor as required under the Employee Retirement Income Security Act of 1974 (ERISA).

- Description of the contribution schedules for the 2023 Plan Year:* **The hourly contribution rate varies by location and negotiated rate. Contributions ranged from 20¢ per hour to 70¢ per hour.**
- Description of the benefit formulas provided under the Plan during the 2023 Plan Year:* **A participant will be credited with a monthly benefit of \$26 for each Plan Year after January 1, 2006 in which he or she is credited with 1,800 or more Hours of Service. A proportional benefit will be earned for a Plan Year that a participant works less than 1,800 Hours of Service. A participant will not earn any benefit for a Plan Year in which he or she is credited with less than 140 Hours of Service. Benefits are payable at a participant's Normal Retirement Date (generally, age 65). The Plan also provides Early Retirement, Vested (with 5 Years of Service), Pre-Retirement Death, and Disability Benefits.**
- Number of employers obligated to contribute to the Plan for the 2023 Plan Year:* **Three.**
- List of employers that contributed more than 5% of the total contributions to the Plan during the 2023 Plan Year:* **Aramark Educational Services LLC, Chartwells - Xavier University, and Cincinnati Sportservice.**
- Number of Plan participants for whom no contributions were made by an employer for the 2023, 2022 and 2021 Plan Years due to employers who withdrew from the Plan:* **Zero.**
- Number of employers that withdrew from the Plan during the preceding Plan Year and the withdrawal liability assessed to these withdrawn employers:* **Zero.**
- Description of the impact of any mergers during the 2023 Plan Year, including information regarding the actuarial value of assets and liabilities of each affected Plan as of the end of the prior Plan Year:* **The Plan did not merge into or with any other pension plan during the 2023 Plan Year.**
- Information on the Plan's 2023 PPA funded status:* **The Plan was certified as not being Endangered, Seriously Endangered, Critical, or Critical and Declining for the 2023 Plan Year.**
- Statement as to whether the Plan requested or received an amortization extension or whether the Plan used the shortfall funding method for the 2023 Plan Year:* **The Plan did not request or receive an amortization extension nor did it use the shortfall funding method for the 2023 Plan Year.**
